Terms and Conditions – ALL VENDORS

- Promotional materials placed outside of the vendor booths (ie walls, fence, poles or chairs) will be fined a disposal fee and will be subtracted from the security deposit.
- Each booth chair and tables will need to be provided by vendor. OEBB is not responsible for lost or stolen items left or stored at the exhibit booths.
- Please do not park your vehicle directly in front of the building unless loading and unloading. After unloading, please move your car so other vendors can load and unload.
- No soda or water allowed to be sold by *any*vendor. OEBB will be providing drink stations to sell those items as their fundraiser. Vendors are allowed to sell any specialty drinks outside of soda and waters.
- Electricity MUST be provided by vendor. Generators can be rented here: https://www.homedepot.com/c/generator_equipment_rental
- Each exhibitor/vendor is to provide Open Eyes Beyond Border (OEBB) with a security deposit of \$100 that will be returned within 30 business days after April 13, 2024, provided rules and regulations of the guideline are met. It is the vendor's responsibility to keep their exhibit space and area safe, clean and free of damage. Vendors are not permitted to move from their assigned location or take tables and/or chairs that are not assigned to them. *Deposit checks can be submitted on a separate check from the space fee. Vendors that submit deposit on a separate check can 'check out' with the Vendor Coordinator after the event to receive deposit check back after the event.
- The OEBB will not accept any claim for loss, due to fire, theft or damage of exhibits, nor will it be held liable for any personal injury caused by the exhibit or exhibitor. Use of the facility is conditional in that the exhibitor accepts full responsibility for any damages caused to the facility by the exhibit and/or the exhibitor(s).

FOOD VENDOR REQUIREMENTS (in addition to above terms/conditions):

- Cleaning and Sanitation Stations at each booth will be provided by the vendor. Water is available on site for use.
- Oil disposal will be the responsibility of the vendor Please discard ALL oil off site. Failure to do so will forfeiting full amount of the security deposit.
- Failure to pass food inspection (in the event we are audited) will result in loss of vendor fees/deposit and will be asked to leave our event.
- Any vendors using active fires on site (by pit or propane), vendor must have a fire extinguisher present. Any propane use on site must be in a safe area away from fire hazards and the public. Any active flames and cooking on site should have protection down on the ground to prevent staining for any stray food/oil.
- Vendors to provide own trash bag/container. We will be adding trash cans throughout the venue but please make sure you have one at your booth. We will be assisting with trash removal but please help us through this if you are able to take your own trash to the dumpsters provided.
- Food permit applications submitted after March 25, 2024 deadline will be subject to a \$50 expediting fee. ID required to pull permit.

Applications will be processed on a first-come, first-paid basis.

Deadline for exhibitors is March 25, 2024. Applications received after this date will not be guaranteed exhibit space.
